All bids by proxy sent using this are submitted with the acknowledgement of the following agreements:

1. Bidding by proxy bid will be done on behalf of the Proxy Bidder as if he were present at the auction and his purchase will be obtained at the lowest bid possible.
2. Bids by proxy are confidential and bidding will not commence with the highest Bid by proxy.
3. The Bidder agrees to be bound by Lindstrand Auctions Ltd. standard Bidders Registration Bid Cards, and the Terms and Conditions of Sale(any announcements at the Auction by the Auctioneer take precedence). The terms and conditions of sale will be forwarded to the Proxy Bidder.
4. Lindstrand Auctions Ltd. does not guarantee the year, condition, description , availability, or suitability of any item.
5. All bidders are responsible to inspect items before bidding. Signing to this proxy bid confirms that the bidder has inspected the item(s) to his satisfaction.
6. Bidder acknowledges that the Bid by proxy is accepted on the express condition that the Bidder will not have any claim against the Auctioneer or its employees if the Auctioneer fails, for any reason, to bid on behalf of the Bidder.
7. A handling fee of 2% will be added to the purchase price on every Lot purchased by Proxy Bid .
8. A 2% Charge will apply to all proxy bid purchases paid by credit card.
9. All Proxy Bid purchases must be paid in Canadian Funds. All proxy bidders are required to obtain a letter of credit and deliver it to us 48 hours prior to sale, and the date of application and delivery must be during regular business hours before 3:00pm. Letter of credit must be printed on the bank or lenders official letterhead and must be in favor of Lindstrand Auctions Ltd., and must be valid for the period of time which would include the auctions you wish to bid at. It must also specify the maximum credit amount available. That amount will be your bid limit. If the letter of credit date has expired or if the credit amount is too low, it must be renewed in order to bid at the next auction. No bid will be accepted that is in excess of the credit amount specified in the Letter of Credit.
10. All Proxy Bid purchases must be paid in full on sale day by the conclusion of the auction, we do not extend credit under any circumstance.
11. All purchases must be removed from the auction site within the time frame stipulated by the auctioneer from the conclusion of the auction. Any items remaining are subject to storage fees and may be resold at the proxy bidders expense . Buyer accepts responsibility of safety and insurance on items after they are sold.
12. Your time is important to us. We appreciate the time you take to participate in our sale and we will do our best to process and submit your proxy bids. However, we do not guarantee that your bid will be accepted and submitted sale day, though will make the best effort to assist you.
13. Lindstrand Auctions Ltd. reserves the right to refuse any proxy bid application. Scanned copy of Drivers license and credit card required.
14. All proxy bids must be submitted 48 hours in advance of the auction.
15. The absentee bid will not be exceeded by any amount.
